MACH IQ is committed to protecting your personal information. This privacy policy explains how we collect and uses the personal information that you provide online to any of us websites, and/or in conjunction with your registration for any of our events (the "Events").

You should read this Policy before you submit any personal information to us. By using our Sites and Events, you consent to the collection and use of your personal information as outlined in this Policy. If you do not agree with the content of this Policy, you should refrain from using our Sites and Events.

This privacy policy has been compiled to better serve those who are concerned with how their 'Personally identifiable information' (PII) is being used online. PII, as used in US privacy law and information security, is information that can be used on its own or with other information to identify, contact, or locate a single person, or to identify an individual in context. Please read our privacy policy carefully to get a clear understanding of how we collect, use, protect or otherwise handle your Personally Identifiable Information following our website.

MACH IQ is a platform service by MachBizz Marketers Pvt Ltd (collectively, "MachBizz") are committed to protecting our users' privacy. This Privacy Policy is designed to inform users of MACH IQ' and how MACH IQ gathers and uses information provided to, or collected by, MACH IQ and under what circumstances MACH IQ will disclose such information. MACH IQ will take reasonable steps to protect user privacy consistent with the guidelines outlined in this Privacy Policy and with the global compliances.

Information we collect:

We collect personally identifiable information when you provide it to us, such as when you register for an event, request information or otherwise communicate with us. We may also receive information about you from other sources and add it to the information you have provided to us.

You are not obligated to provide us with any personally identifiable information, although registration is required to access the full range of information and events offered.

How We Use Your Information?

We may use the information we collect from you when you register for an event or use certain other site features in the following ways:

- To personalize user's experience and to allow us to deliver the type of content and product offerings in which you are most interested.
- To improve our website to better serve you.
- To allow us to better service you in responding to your customer service requests.
- To administer promotional content or other site features.
- To send periodic emails regarding your registration or other products and services.

Events

If you wish to register for our events, we ask for contact information, including but not limited to name and email address. MACH IQ uses this information to fulfil your request for information and, in some cases, personalize the email content for you. All emails have an option to unsubscribe, and requests will be processed immediately.

Third-Party Disclosure

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information unless we provide you with advance notice or if you download vendor-sponsored content (see above) that requires your details be transferred to the said vendor. This does not include website hosting partners and other parties who assist us in operating our website, conducting our business, or servicing you, so long as those parties agree to keep this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others' rights, property, or safety.

MACH IQ, Sites and Other Services

As a MACH IQ customer, you can also expect to receive relevant email and postal offers for other MACH IQ publications, events, sites and services.

Cookies

MACH IQ uses cookies to deliver a better and more personalized service. Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) that enables the site's or service provider's systems to recognize your browser and capture and remember certain information. For instance, we use cookies to help us understand your preferences based on previous or current site activity, which enables us to provide you with improved services. We also use cookies to help us compile aggregate data about

site traffic and site interaction so that we can offer better site experiences and tools in the future.

We use cookies to:

- Understand and save user's preferences for future visits.
- Keep track of advertisements
- Compile aggregate data about site traffic and site interactions to offer better site experiences and tools in the future. We may also use trusted third-party services that track this information on our behalf.

You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies. You do this through your browser (like Internet Explorer) settings. Each browser is a little different, so look at your browser's Help menu to learn the correct way to modify your cookies.

If you disable cookies off, some features will be disabled and some of our services may not function properly. However, you can still register and subscribe for offers and content.

Information Collected Automatically

When you visit the Sites, we automatically collect and analyse certain information about your computer. This information includes but may not be limited to the IP address used to connect your computer to the Internet, information about your browser type and language, the date and time you are accessing our site, the content of any undeleted cookies that your browser previously accepted from us, and the referring website address.

How to Unsubscribe?

If you no longer want to receive marketing communications from MACH IQ, you may unsubscribe by clicking the "Manage My Preferences" or "Unsubscribe" link within the MACH IQ electronic communications, or by otherwise following the instructions to "opt-out" appearing on that communication.

Registration

To use MACH IQ, you may be asked to complete a registration form. During registration, you are required to provide contact information which is used to determine whether you are a subscriber or the authorized employee of a subscriber.

Purchases and Fulfilment

When you place an order or register for an event, we may request additional information such as credit card number and expiration date. This information is used for confirmation and billing purposes. The contact information you provide is used to service the order. Also, when you register for an event, we may request additional information about your hotel, meal and other travel preferences. This information is used only for a specific event.

MACH IQ uses third-party service providers such as credit card processing companies, shipping companies, mailing houses and event coordinators together with other service providers as required to satisfy client requests.

When you register for an event, we provide necessary information to hotels and facilities hosting events. These parties are allowed to use that personal information only to provide services relevant to the event.

Security of Your Information

MACH IQ has implemented generally accepted standards of technology security to protect information from loss, misuse and unauthorized access, disclosure, alteration or destruction. Personally identifiable information is kept securely. Only authorized MACH IQ personnel and agents are provided access to personal information and these employees have agreed to ensure confidentiality of this information.
